Invitation

The International Rail Transport Committee (CIT) has great pleasure in inviting the staff of privacy offices, legal and technical departments of CIT members, dealing with or interested in data protection issues, to the CIT Workshop on Data Protection in International Passenger Traffic, to be held in Bern on Wednesday, 21 June 2017.

New Challenges Relating to Data Protection

Protection of personal data is of great importance in the day-to-day business of railway undertakings in the domestic activities and is increasingly becoming an issue in the international traffic – both in sales and ticketing processes and after-sales activities.

Data protection falls within the scope of fundamental rights and freedoms, namely, the right to privacy of individuals with respect to the processing (collecting, saving or transferring) of personal data. The EU Regulation 1371/2007 on rail passengers' rights and obligations refers in Article 10(5) to the obligation of railway undertakings and ticket vendors not to disclose personal information on individual bookings to other railway undertakings and/or ticket vendors, subject to the EU Directive 95/46/EC on data protection.

Currently, the level of data protection differs across the European Union, with the Directive 95/46/EC on data protection setting some general principles and being a minimum standard. So far, privacy policies implemented by CIT members have been largely shaped by respective national laws implementing this Directive. The new EU General Data Protection Regulation 2016/679 (GDPR) entered into force on 24 May 2016 and will be applicable from 25 May 2018, replacing the Directive 95/46/EC. The GDPR contains more coherent, clear and stringent rules that set a high standard of data protection. It will be directly applicable across the whole European Union.

In the course of 2014-2015 the CIT General Secretariat analysed selected data protection policies of the CIT members and came to a conclusion that a lot of the data protection requirements according to the EU law have been already tackled. Nevertheless, CIT members recognise the need to review their privacy policies in light of the GDPR. To this end, the CIT General Secretariat is preparing the CIT Guidelines on Data Protection to provide guidance to CIT members with respect to data protection requirements according to the GDPR.

Overview and goals of the workshop

During the morning sessions, participants will be given an overview of the implications of the new EU GDPR for railway undertakings in the EU and a third-country perspective on the requirements of the GDPR, taking the example of Switzerland. Participants will also learn about some best practices of GDPR implementation by selected CIT members. Furthermore, the CIT General Secretariat will present the new CIT Guidelines on Data Protection and new provisions on data protection in CIT documents for passenger traffic.

The afternoon session will focus on selected topical issues related to data protection. It will allow participants to learn about potential implications of the most recent business and policy developments in the rail sector from the perspective of data protection compliance.

The workshop will conclude with a practical session addressing three cases in light of the requirements of the GDPR and will allow participants to discuss their current data protection practices based on these cases.

The workshop will offer good opportunities for networking and participants will be able to discuss unclarified issues or disputed cases also on bilateral basis. Where necessary, the CIT General Secretariat may facilitate contacts between the participants.
