Invitation

The CIT has great pleasure in inviting the staff of privacy offices, legal, business and technical departments of CIT members, dealing with or interested in data protection issues, to the CIT Conference “Future Questions of Data Protection”, to be held in Berne on Thursday, 15 June 2023.

Challenges relating to Data Protection and future questions – scope of the conference

Protection of personal data is of great importance in the day-to-day business of railway undertakings in their domestic activities and in international traffic. Personal data is everywhere: in the information provided when buying tickets, when handling claims or when someone signs a contract of carriage of goods. New technologies will bring progress to the railway sector, but also raise new legal questions about data protection.

With the EU General Data Protection Regulation (GDPR) a strong privacy and security law became applicable from 25 May 2018 all over Europe. Based on the GDPR, the CIT developed a Manual on Data Protection for Transport Undertakings that encompasses commentaries to each article of the GDPR as well as guidelines and boilerplate contracts.

However, data protection is not limited to the GDPR. In the European Union, the General Data Protection Regulation will soon be joined by a number of new regulations such as the Data Governance Act, the Data Act, the Digital Services Act or the Digital Markets Act to name a few. These legal acts do not exclude personal data from their scope, but they focus primarily on how companies handle and use data.

In addition, it will become more and more crucial to protect data from external attacks. This brings cybersecurity into focus.

Target Audience

Employees of the CIT members, working or interested in the field of data protection (e.g. data protection officers or experts, lawyers) in the passenger traffic but also in the freight traffic.

Participation

We recommend that you attend the event in person. This way you can meet your colleagues from the other CIT members and benefit from the networking opportunities. However, we will allow on request a limited number of participants to join the conference online as well. For participants who will be attending online by MS Teams, the link to connect will be sent to you a few days before the meeting.
